#### Key remarks by the EACEA:

- "The consortium is recommended to report about the main **results of evaluations** of training programmes and to elaborate how the results of evaluations of numerous training programmes were integrated in the potential **revisions of the educational programmes.**"
- "Due to the fact that CoVEs operate as a three level tier, there are strong cooperations between educational institutions on initial vocational level, further vocational level and at higher education level. The project is recommended to support the evidence on these strong relationships with an **overview of quantitative details** regarding the level of involvement **of different stakeholders** in each CoVE."
- "The project is recommended to provide a more detailed overview of quantitative achievements related to dissemination activities."


